THE RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016 ACT NO. 49 OF 2016 PURPOSE:

TO ENSURE THAT ALL STUDENTS, STAFF, AND VISITORS WITH DISABILITIES:

- 1. HAVE EQUAL ACCESS TO EDUCATION,
- 2. RESOURCES AND FACILITIES
- 3. PROMOTING AN INCLUSIVE
- 4. SUPPORTIVE, LEARNING ENVIRONMENT

SCOPE

THIS POLICY APPLIES TO ALL EDUCATIONAL INSTITUTIONS, INCLUDING CLASSROOMS, LIBRARIES, LABORATORIES, AND OTHER FACILITIES.

DEFINITIONS

- (r) "person with benchmark disability" means a person with not less than forty per cent. of aspecified disability where specified disability has not been defined in measurable terms and includes aperson with disability where specified disability has been defined in measurable terms, as certified bythe certifying authority;
- (s) "person with disability" means a person with long term physical, mental, intellectual orsensory impairment which, in interaction with barriers, hinders his full and effective participation insociety equally with others;
- (c) "barrier" means any factor including communicational, cultural, economic, environmental, institutional, political, social, attitudinal or structural factors which hampers the full and effective participation of persons with disabilities in society;-
- (m) "inclusive education" means a system of education wherein students with and without disability learn together and the system of teaching and learning is suitably adapted to meet the learning needs of different types of students with disabilities;

POLICY STATEMENT
