William Shakespeare's "The Tempest" is multi-theme romance. It deals with infringe of Human Rights by referring the characters like Prospero, Miranda, Caliban and Ariel. Human Rights means natural rights. Right to life is deprived to Prospero, Miranda, Caliban and Ariel.

William Shakespeare is one of the greatest dramatists in the galaxy of the world literature. He wrote well-known tragedies, comedies, romances, historical plays and Roman plays along with 154 sonnets. "The Tempest" is romance which shows infringes of human rights of Prospero, Miranda his daughter, slave Caliban and Ariel. Human rights means a natural rights. The Universal Declaration of Human Rights, Article 1 provides "All human beings are born free and equal in dignity and rights, they endowed with reason and

conscience and should act to one another in spirit of brotherhood"

European Convention for the Protection of Human Rights and Fundamental Freedoms Section 1, defines the following rights and freedoms as 'Right to life (Article 2), Freedom from torture or inhuman or degrading treatment or punishment (Article 3), Freedom from slavery (Article 4). American Convention on Human Rights guarantees the following rights as the right to life (Article 4), the right to human treatment (Article 5), freedom from slavery (Article 6) and right to personal liberty (Article 7).

"The Tempest" is a juicy sugar-cane for the critics. They suck the melodious juice and express various titles to the sugar cane. Some critics say that it is last play of Shakespeare. It is full with autobiographical elements. The play has a theme of reconciliation and forgiveness. It has colonial elements etc. It has another theme which is very significant in the recent times that is infringes of the human rights.

The story begins with shipwreck. Prospero was the real Duke of Milan. He had abandoned from his own kingdom by the treachery of his own brother named Antonio. He had habits of reading so he spent all

times in reading and invested the ruling rights in his brother's hands. He was the real ruler of Milan. Taking the advantages of his rights he abandoned his brother in a boat which was leak. Gonzalo the old noble man who took pity on Prospero and his five years daughter named Miranda by giving them, without knowing to Antonio put some food, drink, books and clothes. The natural rights of Prospero and his daughter is infringed by Antonio. They reached on the island of which belonged to Caliban.

Caliban is the native of that island. His mother was a witch named Sycorax. Prospero captured that whole island in his hands when he became the master in the magic. Another character in the play is Ariel who is a fine spirit representing the goodness quality. He had fallen in the hands of witch named Sycorax. He had imprisoned by Sycorax in a cloven pine tree. Sycorax had died.

Here the natural rights of Ariel is infringed by the witch Sycorax in the same manner by Prospero infringes rights of Caliban. Prospero released him from

the pine tree. Then he served to Prospero. Caliban become a slave in the hands of Prospero. His feelings captured island by Prospero is expressed in Act I Scene II

This island is mine, by Sycorax my mother,

Which thou takest from me"
